1. COLLECTION AND USE OF YOUR PERSONAL INFORMATION

Magna Capital Limited("Magna") respects the privacy rights of our clients. Our Privacy Policy will help you understand what personal data we collect, why we collect it and what we do with it. Please take a moment to familiarise yourself with our privacy practices and let us know if you have any questions by sending us an email or submitting a request through our website.

Magna collects personal information that you voluntarily provide on this Web site or offline in connection with your account application, which may include your name, address, email address, contact information, etc.

Do not provide information about others unless you are authorized to do so and consent to have all information used, disclosed, and transferred in accordance with this Privacy Policy. By submitting the information about others, you represent and warrant that you are authorized to do so and that you have received authorization from the person about whom you are providing the information and that person has consented to have all information used, disclosed, and transferred in accordance with this Privacy Policy.

We use this information for carefully considered business purposes, which include some or all the following to:

- communicate with you
- provide our services and products
- help Magna improve our services and products and develop new services and products
- provide support for our services and products, and for internal quality control purposes
- provide you with offers and promotions about services and products of Magna or of other parties that may be of interest to you
- enhance your experience with this Web site, including to save your preference and login information
- analyse web site usage and analyse use of the Web site
- protect the interests, rights, safety of Magna and to monitor compliance with and enforce the terms of any agreement with Magna
- operate our services, products, and systems properly.

2. USE OF COOKIES AND OTHER ELECTRONIC TOOLS

Magna and the parties with whom we work (e.g., service providers, business partners) may place, view, and/or use "cookies", Web server logs, Web beacons, or other electronic tools to collect statistical and other information about your use of this Web site and other websites. Magna and the parties with whom we work may use the information collected for various reasons, either on behalf of Magna or for the other



parties' purposes, including research, analysis, to better serve visitors to this Web site to compile aggregate and anonymous information about usage of this Web site and other websites, other statistics, etc. However, if you have deleted and disabled cookies, these uses will not be possible to the extent they are based on cookie information.

To assist us with the uses described in this Privacy Policy, information collected about your use of this Web site or other websites may be aggregated, analysed, or combined with personal or other information about you from other online or offline sources. If you prefer that we not combine non-personal information that has been collected, through cookies, about your use of this Web site or other websites with personal or other information about you, then please delete and disable cookies for each browser, on each computer you use to surf the Web.

Most browsers are set to accept cookies by default. If you prefer, you can usually set your browser to disable cookies, or to alert you when cookies are being sent. Likewise, most mobile devices allow you to disable the ability for geo-location information to be collected from your mobile device. The help function on most browsers and mobile devices contains instructions on how to set your browser to notify you before accepting cookies, disable cookies entirely, or disable the collection of geo-location data. You need to set each browser; on each device you use to surf the Web. Thus, if you use multiple browsers (e.g., Chrome, Safari, Internet Explorer, Firefox, etc.), you should repeat this procedure with each one. Similarly, if you connect to the Web from multiple devices (e.g., work and home), you need to set each browser on each device. Depending on your jurisdiction, you may be able to utilize additional cookie management tools. However, if you disable cookies or refuse to accept a request to place a cookie, it is possible that some parts of this Web site, such as polls, surveys, contests, and product sales, and certain areas of the Web site for which you need to log in, will not function properly, and the notifications you receive when you visit this Web site may not be advertisements tailored to your interests.

3. DISCLOSURE OF YOUR PERSONAL INFORMATION

Magna may also disclose your personal information to unaffiliated third parties if we believe in good faith that such disclosure is necessary to: (a) comply with any applicable law, rule, or regulation, or in response to a subpoena, court order, or other legal process, subject to Magna's Law Enforcement Data Request Statement; (b) protect the interests, rights, safety, or property of Magna or others; (c) monitor compliance with and enforce any terms of service on this Web site; (d) provide our services and products (including allowing a purchaser of Magna or a Magna division to continue to serve you); (e) perform other activities



related to such services and products, including billing and collection; (f) provide you with offers or promotions from Magna; or (g) operate the systems that provide our services and products properly.

The collection, further use, and/or disclosure of your information by Third-Party Providers or by other third parties is not the responsibility of Magna. Rather, such collection, use, and/or disclosure is governed by the third parties' privacy policies.

4. ACCURACY, SECURITY, AND RETENTION OF YOUR PERSONAL INFORMATION

Any personal information you provide to Magna is kept on secure servers. Magna uses security measures appropriate to the provision of the relevant product or service, such as reasonable administrative, technical, personnel, and physical measures (a) to safeguard personal information against loss, theft, unauthorized use, disclosure, or modification; and (b) to ensure the integrity of the personal information. To help us protect your privacy, you should maintain the secrecy of the logon ID and password you may have set up in connection with your participation in our services. Personal information is retained for as long as is necessary for the purpose for which it is collected, including legitimate business reasons, and/or legal and regulatory requirements.

5. RIGHTS WITH RESPECT TO YOUR PERSONAL INFORMATION

Depending on the jurisdiction, you may have the right to access, correct, delete, or restrict use of certain personal information covered by this Privacy Policy. Depending on the jurisdiction, you may also have the right to request that we refrain from processing personal information. While Magna will make reasonable efforts to accommodate your request, we also reserve the right to impose certain restrictions and requirements on such requests, if allowed or required by applicable laws. Please note that it may take some time to process your request, consistent with applicable law.
